1. A 'Walk-in-Interview' will be held at this Institute on **27 Oct 2021 at 1000 Hrs** for selection of a suitable candidate for the position of **Junior Research Fellow (JRF)** to work in **ARMREB** Sponsored Research Project entitled "**Studies on Self Healing Properties of Microencapsulated Species in HTPB Based Binder System**". Details/eligibility conditions for selection are given hereunder: -

**Note-1 :** (\*) 'The crucial date' for determining the upper age-limit is **27 Oct 2021** (i.e. on the date of Walk-in-Interview/Selection Meeting'). Upper age-limit is relaxable up to 05 years in case of candidates belonging to Scheduled Castes & Scheduled Tribes, Women and PH and up to 03 years in case of candidates belonging to OBC.

**Note-2:** (@) Accommodation in the Institute campus is likely to be available on payment basis. In addition to the monthly stipend, Medical facilities limited to MI Room facilities will be extended to the incumbent.

**Note-3:** **Recruited JRFs and fellowship candidates will be encouraged to register for Ph.D at this Institute through proper channel as per DIAT norms.**

2. An 'Aptitude Test' for ascertaining the aptitude of the candidates for research will be conducted by an Expert Committee during the 'Interview'.

3. Interested candidates fulfilling the eligibility conditions for Junior Research Fellowship as mentioned in Para 1 above, may attend the 'Walk-in-Interview' at this Institute on **27 Oct 2021 at 1000hrs**, along with filled up application form downloaded from DIAT website, original Certificates/Testimonials etc (together with a set of attested copies of each) for detailed scrutiny. Candidates working in Government/Public Sector Undertakings/Autonomous Bodies should produce a 'No Objection Certificate' from the present employer. No TA will be paid for attending the 'Walk-in-Interview'.

4. The prescribed educational qualification are the bare minimum and mere possession of the same does not entitle the candidates to be considered at every stage of the selection process. In case of a large number of applications, based on the recommendations of the Screening Committee, the Principle Investigator may restrict the number of candidates to be called for the interview to a reasonable limit after taking, the qualifications and experience over and above the minimum prescribed in the advertisement, into consideration. Therefore, it is the interest of the candidates, to mention all the qualification and experience in the application clearly with supporting documents.
